Our annual certification audit was performed between 7 and 10 October 2019. A follow-up audit was performed on 13 and 14 January 2020. The result of these audits is that we conclude, based on the objective evidence collected during these audits,

- between 15 November 2018 and 14 November 2019, the areas assessed relevant for the services under the PKIoverheid G2 root during the audit were generally found to be effective;
- between 17 July 2019 and 14 November 2019, the areas assessed relevant for the services under the PKIoverheid G3 root during the audit were generally found to be effective,

based on the applicable requirements defined in Human Environment and Transport Inspectorate's Statement of Applicability, dated 15 January 2020 and the Overview of Applicability, dated 3 July 2019.
